In order to resolve this matter, the Nebraska Department of Insurance ("Department"), by and through its attorney, Krystle Ledvina Garcia, and Association & Society Insurance Corporation ("Respondent"), mutually stipulate and agree as follows:

## **JURISDICTION**

- 1. The Department has jurisdiction over the subject matter and Respondent pursuant to Neb. Rev. Stat. §§ 44-101.01, and 44-5801 (Reissue 2010).
- Respondent is a licensed third-party administrator existing under the laws of the State of Maryland. Respondent is licensed to engage in the business of insurance in Nebraska as a thirdparty administrator.

#### STIPULATIONS OF FACT

1. The Department initiated this administrative proceeding by filing a petition styled State of Nebraska Department of Insurance vs. Association & Society Insurance Corporation, Cause Number C-2147 on May 28, 2015. A copy of the petition was served upon the Respondent by certified mail, return receipt requested.

- 2. The petition alleges that Respondent violated Neb. Rev. Stat. § 44-5814(1) by not filing its annual report with the Department on or before March 1, 2015.
- 3. On or about March 31, 2014, Respondent was acquired by Selman & Company. On or about April 25, 2014, Respondent changed its name to Izzy, Inc. Respondent is not currently conducting any insurance business.
- 4. Respondent was informed of its right to a public hearing. Respondent waives that right and enters into this Consent Order freely and voluntarily. Respondent understands and acknowledges that by waiving the right to a public hearing, Respondent also waives the right to confrontation of witnesses, production of evidence, and judicial review.
  - 5. Respondent admits the allegations stated in Paragraph 2 and Paragraph 3.

## **CONCLUSIONS OF LAW**

Respondent's conduct as alleged above constitutes violations of Neb. Rev. Stat. §§ 44-5814 (1) (Reissue 2010).

#### CONSENT ORDER

It is therefore ordered by the Director of Insurance and agreed by Respondent that it shall withdraw as a third-party administrator licensed to do business in Nebraska and surrender its certificate of authority to the Director on or before thirty (30) days from the date the Director signs this Consent Order. The Nebraska Department of Insurance shall retain jurisdiction of this matter for the purpose of enabling the Respondent or the Department to make application for such further orders as may be necessary.

In witness of their intentions to be bound by this Consent Order, the Department of Insurance for the State of Nebraska and Association & Society Insurance Corporation hereby sign this Consent Order by and through their authorized representatives.
