Mount Vernon Fire Insurance Company ("MVFIC") is a Pennsylvania domiciled property insurance company that has applied to the Director of Insurance of the State of Nebraska ("Director") for approval to change its domicile from Pennsylvania to Nebraska. After reviewing the filings, correspondence, and all pertinent information provided to the Nebraska Department of Insurance ("Department"), the Director hereby approves the application and finds, concludes, and orders as follows:

FINDINGS OF FACT

- 1. On or about September 10, 2021, MVFIC filed an application and a plan to redomesticate from Pennsylvania to Nebraska pursuant to Neb. Rev. Stat. §§ 44-161 through 44-164 and the provisions of the Nebraska Model Business Corporation Act. Said application and plan was supplemented as necessary throughout the Department's review process.
- 2. MVFIC is a Pennsylvania domiciled property insurance company that has applied for and, in conjunction with the redomestication, will receive a certificate of authority to transact the business of insurance in the State of Nebraska.
- 3. MVFIC desires to change its domicile from Pennsylvania to Nebraska and the Board of Directors of MVFIC has determined that it is in the best interest of MVFIC and its shareholders to become a domestic insurance company in the State of Nebraska. MVFIC is also

part of the Berkshire Hathaway Inc. holding company system and desires to redomesticate for greater regulatory consistency across all companies within its holding company group.

- 4. On November 2, 2021, the Deputy Insurance Commissioner of the Commonwealth of Pennsylvania issued an Order approving MVFIC's redomestication to Nebraska.
- 5. The Board of Directors of MVFIC approved the redomestication on September 8, 2021 and will cause MVFIC to file Articles of Domestication, Amended and Restated Articles of Incorporation, and By-laws for MVFIC to affect the transfer of domicile to Nebraska.
 - 6. The shareholders for MVFIC approved the redomestication on September 8, 2021.
- 7. MVFIC has submitted all documents, information and filings required by Nebraska law and the Department, including the application, plan, Articles of Domestication, Amended and Restated Articles of Incorporation, By-laws, and evidence of the statutory trust deposit.
- 8. The redomestication to Nebraska is to become effective at 8:00 A.M., Eastern Standard Time, on December 20, 2021.

CONCLUSIONS OF LAW

- 1. The State of Nebraska Department of Insurance has jurisdiction over the subject matter and the parties to this transaction pursuant to Neb. Rev. Stat. §§ 44-101.01 and 44-161.
- 2. The approval of this application, Articles of Domestication, Amended and Restated Articles of Incorporation, and By-laws will not, in any manner, impair the rights, remedies, or security of any existing policyholders of MVFIC.
- 3. The Articles of Domestication, Amended and Restated Articles of Incorporation, and By-laws comply with the applicable Nebraska laws and should be approved.
- 4. After the redomestication, MVFIC will meet all requirements for holding a Certificate of Authority as a Nebraska domestic property and casualty insurer.

5. The application complies with all requirements of Nebraska law and should be approved.

<u>ORDER</u>

IT IS THEREFORE ORDERED that the application of Mount Vernon Fire Insurance Company to transfer its domicile from Pennsylvania to Nebraska is hereby approved with the transfer effective as of 8:00 A.M., Eastern Standard Time, on December 20, 2021.

The Nebraska Department of Insurance will issue Mount Vernon Fire Insurance Company a certificate of authority to carry out the business of insurance as a domestic property and casualty insurer in the State of Nebraska.
